

# Guide for beneficiaries

## Dear Customer,

In light of the cessation of activity of Svea Solar Spain, we have prepared this guide to help you continue with the procedures related to renewable energy subsidies in case you are affected. Below, we explain how to proceed depending on your situation.

# What should the beneficiary do?

- If the application was submitted by the installation company (SVEA SOLAR) as a representative: Contact the granting body of your Autonomous Community (CCAA) to find out the status of your application. You may need to arrange a change of representation to access the file and complete the required procedures.
- If the application was submitted by the beneficiary: You have access to the processing platform and can directly check the status of your application. Make sure you have all the necessary technical documentation, such as invoices, photos and technical certificates. You may need a third party to complete or sign some technical documents required by the Public Administration.

# Types of grants and relevant contacts:

- Energy Efficiency Subsidy (P4 Program): Contact the collaborating company CDC (a.sanchez@certificadodecasa.com).
- Energy Efficiency Certificates (CEE) for personal income tax deduction: Contact the collaborating company CDC ( <u>a.sanchez@certificadodecasa.com</u> ).
- European Grant (Next Generation ): If the application was managed by Svea Solar, it is recommended to look for a company to continue the procedures. Consult CDC ( <a href="mailto:a.sanchez@certificadodecasa.com">a.sanchez@certificadodecasa.com</a>) for the possibility of continuing the management as part of its services. Remember that this grant ended its application period last December 2023.
